

## Gerringong Village Market Conditions

Gerringong Village Markets reserve the right to accept or reject any application by a stallholder. By accepting a stall site at our market you are agreeing to comply with Gerringong Village Market Conditions. Stallholders are required to arrive in plenty of time to set up and be ready to operate by 8.30 am.

**PLEASE NOTE:** Vehicles are to be removed away from the market site, Noble Str. & Belinda St. during trading hours. Parking for stallholders is available opposite the market in the Anglican Church grounds.

Stallholders are not to leave the site before 1.30 pm.

Vehicles are to enter the market at the rear of the Town Hall in Noble Street (via Belinda St.) and to drive at walking pace while travelling in the Market Area. Vehicles must not drive on the central grassed areas of the park.

All electrical equipment being used must be tested and labelled accordingly, LPG gas bottles to have compliance stamp.

Tents are to be securely held to the ground to prevent being uplifted by winds. Trip points, such as tent pegs & guy ropes, positioned so as not to cause a hazard.

**All stallholders are required to leave their stall site clean and tidy and to take their own generated rubbish away from the market area.**

**All stallholders are required to provide:**

- a) Proof of Public Liability & Product Liability Insurance
- b) Food stallholders to have a temporary Food Permit from Kiama Council

Site Fees: start from \$45 depending on size and location

### **Payment of site fees:**

It is required that all stallholders pay online into the clubs nominated bank account:

Other arrangements for payment may be accepted with approval of the Market Management.

### **Site Booking:**

- Regular stallholders, who wish to retain their agreed site must make a payment no later than the Wednesday prior to the Saturday market.
- New stallholders, once approved by Market Management to attend, must make a payment no later than the Wednesday prior to the Saturday market. A site will be allocated by Market Management.

### **Cancellation fees:**

Regular stallholders who wish to retain their site are required to:

- Provide at least one week notice and pay a site reservation fee of \$20.
- Late or no notice will require full payment of the site fee.
- Gerringong Market is an all-weather market, all stallholders with Hall sites are expected to attend the market regardless of the weather. When appropriate, outside stallholders need to contact Market Management (available from 5.00am on the morning of the market) to determine if weather conditions are suitable.

If a **stallholder wishes to include different or new products to their existing range** they are required to seek approval of the Organisers.

The stallholder agrees to indemnify Gerringong Village Markets & Kiama Council against all liability claims, demands, expenses, fees, fines, penalties, suits, proceedings and actions of any kind.
